- 1)** \* If your total utility construction revenue is under 1 million you may qualify for at 50% discount of NUCA of Pennsylvania's Level 1 portion of dues with proof of total revenue - reducing your total dues to: *Level 1*: 1755 and *Level 0*: 1440. (Acceptable proof: Certified CPA Statement of Volume or Page 1 of your Federal Income Tax Return) PROOF WILL BE CONFIDENTIAL. A CPA Statement form will be sent directly to your CPA upon NUCA PA's receipt of your CPA's contact address.
- 2)** Contractor Dues are pro-rated on NUCA Pennsylvania's portion of dues only after April 1.
